Buskers must follow the guidelines below.

- Buskers may not actively solicit donations at the Market. A passive donation jar/hat/instrument case for tips is permitted.
- Buskers may not amplify sound.
- Buskers may not display/offer for sale any merchandise.
- Buskers shall provide performances, including lyrics, that are appropriate for all ages
- The NCFMA retains the right to regulate the time, place and manner of activities relating to displays, signs and other expressions of the interests represented. The Market Manager may prohibit the use of “fighting words,” obscenities, grisly or gruesome displays or highly inflammatory slogans likely to provoke a disturbance.
